

### *P.A.N.T. Detectives Arrest several following Search Warrants at Prescott area Motels*

Between Friday September 12, 2014, and Saturday September 13, 2014, Partners Against Narcotics Trafficking-PANT detectives obtained and investigated drug related information developed from a fraud schemes investigation with Prescott Police Detectives. PANT officers were able to locate and identify numerous persons involved in illegal drug activity. Multiple search warrants were served at two local Prescott motels. As a result of the search warrants, the following persons were arrested and charged with the indicated crimes. All suspects were booked into the Yavapai County jail. As a result of these arrests, a total of three weapons were recovered in conjunction with approximately ¼ pound of Methamphetamine, Marijuana, Heroin and hallucinogenic "Mushrooms".



Jennifer Nichols- age 26

Possession/use of dangerous drugs-Meth, Possession of dangerous drugs for sale-Meth, Possession/use of dangerous drugs- Psilocybin "mushrooms", Possession of dangerous drugs for sale- Psilocybin "mushrooms", Possession of dangerous drugs-Ecstasy, Possession of a narcotic drug-Heroin, Possession of a narcotic drug for sale-Heroin, Possession of drug paraphernalia. She remains in-custody on a \$5000 bond.



Diana Springs- age 54

Interfere with a judicial proceeding "arrest warrant", Possession of dangerous drugs-Meth, Possession of dangerous drugs for sale-Meth, Possession of drug paraphernalia. Springs was released on a \$3000 bond.



Cynthia Castillo- age 41

Possession/use of dangerous drugs-Meth, Possession of dangerous drugs for sale-Meth, Possession of a dangerous drug-Ecstasy, Possession of a narcotic drug-Oxycodone, Possession of a firearm during a drug related felony, Possession of a firearm by a prohibited possessor, Possession of drug paraphernalia. Castillo released on a \$2000 bond.



Marcos Larrazolo- age 21

Possession/use of dangerous drugs-Meth, Possession of dangerous drugs for sale-Meth, Possession of a firearm during a drug related felony, Possession/use of marijuana, Possession of drug paraphernalia. He remains in-custody on a \$2500 bond.



Gloria Castillo- age 20

Possession/use of dangerous drugs- Meth, Possession/use of marijuana, Possession of drug paraphernalia-Meth, Possession of a firearm during a drug related felony. Castillo was released pending further investigation.



Matthew Masing- age 29

Possession of a Narcotic Drug-Heroin, Possession of a firearm during a drug related felony, Possession of Drug Paraphernalia. Masing released on a \$2000 bond.
